

The Center for Individual & Family Counseling- Clinical counselors and social workers provide therapeutic counseling to children, adults and families coping with cancer. Because many clients in these situations are home-bound, house visits are required about 40% of the time. Clients are offered solution-based interventions that address issues which arise from cancer treatment, depression, communication within the family and/or with healthcare professionals, and maintaining hope. Treehouse Children's Services- Clinical counselors and social workers provide school-based support groups and individual counseling to children who are coping with cancer personally, within the family, or have experienced the loss of a loved one due to cancer.
